Finance Committee Report- Kathy Peterson on behalf of Finance Committee recommends to Approve August 2023

Recommend waiting on Big Valley Joint Unified School District Superintendent and or Board to reply to our letter from SCCSD Board written by our attorney. They have 3 months to reply according to the terms of our lease.

CFO Report- Sara Edson attends via telephone. In August I reviewed the outstanding receivables for EMS and wrote off \$22,000 from 2022-2023.

If we can postpone any expensive vehicle repairs/maintenance until January after we receive our first tax check it would be helpful to our budget.

We have \$4500 in savings per our agreement of depositing \$1500 per month to that account.

District General Administrator Report- Most of the major repairs have been completed on our HTS vehicles. The Toyota Sienna needs tires. After inspection we have discovered that the build up on this vehicle is not the greatest and it affects the wear on the tires.

We will go ahead with the purchase of a 2023 Outback Suburu base model and a 2023 Crosstrek Suburu base model from Klamath Falls Suburu. We will put \$8000. down payment on each that we had set aside from the crashed Suburu. The payments will be approximately \$530 per month. We need confirmation on what interest payment will be and finalize some things first on the financing. We need to find out if the District will be building credit with these purchases.

I have sent Ted at Supreme Graphics in Susanville the final proof on our mailer.

Hue and Cry were here today for our annual inspection and it went well.
